Other events and activities?

These are paid for separately. They are always on a "best value for money" basis and for big events we can look for opportunities to help young people raise funds to reduce the cost of the events.

Trips and days outs are at the best prices we can get - usually helped along by group discounts!

We operate an **Activity Bank** payment scheme, which allows you to pay for events and have a record of the payments made. We provide regular statements to your email address, along with news and information about Group activities.

We want our members to get as much out of Scouting as possible and we're always happy to discuss any difficulties around payment.

What about uniforms and equipment?

Wearing a uniform is comfy and practical. It means no one feels uncomfortable or left out and helps everyone feel part of the group.

There are some activities and events when uniform is not needed, and we let you know this in advance. Our uniform consists of a sweatshirt (Beavers and Cubs) or shirt (Scouts and Explorers) and a "Red McLean" tartan scarf or 'kneckie' to represent the Scout Group.

Kneckies are also available from us in the Scout Hall, currently £10 each. Just ask.

Where do all those badges go?

Well, you can download a helpful guide from the **Parents Page** of our website, to make sure they end up in the right place!

Anything else we'll need?

For activities such as hikes and camps, you'll need to have access to some other personal kit, such as:

- Rucksack
- Sleeping bag
- Walking boots
- Waterproofs

Whilst you may want to have your own items, we maintain stocks of these items and you may be able to borrow from us when taking part in activities that might need them.

Staying informed

- We have closed **facebook groups** for each of our Sections (Beavers, Cubs, Scouts and Explorers) for messages and information, access available only to parents of members
- We'll send you a **regular e-mail**, normally on Sunday evening. It lets you know if your monthly fees are paid and will show you a record of payments for trips and camps (your Activity Bank).
- We'll send you a **regular newsletter**, usually every three months, with news, stories and photos about what's going on across the whole Scout Group
- Our Sections have individual **e-mail** addresses and will use these to contact you. We don't use personal e-mails for Scouting business.

Young People's Information

Along with most other Scout Groups, we use an online tool called **Online Scout Manager (OSM)** to store the information we need to allow your youngster to get the most out of being a member of the Scout Group. OSM is compliant with UK GDPR requirements.

You will be given access to OSM through a **Parent Portal**, allowing you to see what personal details and information we hold, and more importantly, allowing you direct access to change the information and make sure it is completely up to date. It's particularly important that any health-related information is provided and kept up to date.

You'll be given access to the Parent Portal as soon as your youngster is given a joining date and we would ask you to fill in the information we need. OSM also allows you to see all the requirements for our Scout badges and awards and to follow your youngsters' progress. You can even upload documents as evidence to complete some badges and awards!

We might use an OSM-based email system to send out Section messages to you.

In Touch by phone

- During meetings in the Scout Centre, our contact is landline 01383 695142
- For outside events and activities, we have a special In Touch telephone number which is only used during activities outside the Centre and we'll provide that when needed
- We don't use or provide the personal phone details of our adult Leaders

Gift Aid it!

We can increase the value of your monthly subscription payments by 25% through the Gift Aid scheme. This allows charities to claim the tax which the Government has collected on your earnings. To qualify for this scheme, you should have paid an amount of UK tax (Income or Capital Gains) equivalent to the amount being claimed in that year under Gift Aid.

This can mean thousands of pounds for our Scout Group - each year. It's an amazing amount of money, helping to keep subs low. **PLEASE**, if you are a UK tax payer, follow this link on our website to complete the declaration. Takes just a few minutes:

Top Tips

- Please return forms and make payments on time. You can speak to the Section Leader in confidence if you have any problems with this
- Deliver and collect at appropriate times and places
- Check an adult leader has arrived before leaving your child
- Children are never left alone but if collection of your youngster is consistently late we may need you to put in place other safe arrangements
- Ensure your child wears suitable clothing and footwear - soft sole shoes in our Centre please!
- Keep **OSM** details up to date at all times
